

A USER AGREEMENT AND EXPRESS ASSUMPTION OF RISK BY TRIP MEMBERS AND LIMITATION OF RESPONSIBILITY OF WORLD CLASS OUTFITTING ADVENTURES, INC.

I assume for myself, my family, including minor children FULL RESPONSIBILITY for any injuries or damages, which may occur to us as participants while engaging in the activities of the contracted events and do fully and forever release the Company, its Owners, Employees and Agents from any and all claims, demands, damages, rights of action or causes of action present or future, whether the same be known, anticipated, or unanticipated resulting from or arising out of the participants commencement of activity, or use of the facilities, equipment and property of WORLD CLASS OUTFITTING ADVENTURES, INC.

parent/guardian of _____ understand and agree that any bodily injury, death or loss of personal property and expenses thereof result of my negligence or the negligence of my family participating in the scheduled activities contracted for, including minor children and other members of my family, are my responsibility. I also state and acknowledge that activities associated with camping, the riding of animals, backpacking, climbing, wilderness travel and living, collision with a vehicle, vessel, rock, log, tree, immersion in water and hypothermia (rapid and medically serious loss of body temperature), falling while aboard a vessel, animal or on the shore, accidents or illness in remote places without medical facilities, physician or nurses, and exposure to temperature extremes or inclement weather and in consideration of and as a part payment for the right to participate in these activities with WORLD CLASS OUTFITTING ADVENTURES, INC. and its agents and associates, I DO VOLUNTARILY PARTICIPATE IN THESE ACTIVITIES SCHEDULED BY AND ANY RELATED ACTIVITIES WITH THE KNOWLEDGE AND UNDERSTANDING OF THE DANGERS AND RISKS INVOLVED AND HEREBY AGREE THAT MYSELF AND MY FAMILY INCLUDING MINOR CHILDREN are in good health and with no physical defects that might be injurious to me and that myself and my family are able to handle the hazards of traffic, weather conditions, animals, walking, riding and all any similar conditions associated with the activities scheduled or associated with our outdoor adventure.

I UNDERSTAND THAT ANY ROUTE OR ACTIVITY CHOSEN AS A PART OF OUR OUTDOOR ADVENTURE MAY NOT BE THE SAFEST BUT HAS BEEN CHOSEN FOR ITS INTEREST AND CHALLENGE. SINCE ANIMALS ARE USED AS A PART OF OUR ACTIVITIES, I AND MY FAMILY UNDERSTAND THAT AN ANIMAL IRRESPECTIVE OF ITS TRAINING AND USUAL PAST BEHAVOIR AND CHARACTERISTICS MAY ACT OR REACT UNPREDICTABLY AT TIMES, BASED ON INSTINCT OR FRIGHT WHICH, LIKEWISE IS AN INHERENT RISK TO BE ASSUMED BY EACH PARTICIPANT IN THE ACTIVITY.

This EXPRESS ASSUMPTION of RISK and RELEASE of LIABILITY also acts as a Waiver for any protection that may be afforded by any statute or law in any jurisdiction for whose purpose, substance, and/or effect is to provide that a general release shall not extend to claims, material or otherwise, which the person giving the release does not know or suspect to exist at the time of executing this RELEASE OF LIABILITY.
